Applications are typically posted to the Environmental Bill of Rights Registry for public review and comment. In most circumstances, additional consultation is not required by the Section 9 process. However, an applicant may be required to make notification under other legislative requirements, or conduct ongoing public consultation/ notification at the facility with a community liaison group or public groups with an interest in the application. If there is the potential for significant local concerns, the applicant may consider contacting the local District Office prior to making the application. The following are examples of when pre-consultation may be required or should be considered:

- Legacy concerns associated with the site (i.e., odour, noise, etc.)
- Facility processes and activities include new technology or unknown technology, which are not currently permitted within the province
- Facility processes and activities may require additional technical studies (i.e., flare assessment, fogging and icing, odour, etc.)

The above are only provided as examples; there may be other circumstances for which preconsultation is required. If the applicant is unsure, contact the local District Office.
